- 1. This policy is based on fairness to everyone (that is, same requirements and restrictions as well as benefits across the board) who wishes to seek income from selling anything Halal in the compounds of the Upstate Islamic Center (UIC), and to not put undue hardship and restrictions on any vendor.
- 2. Each vendor needs to take prior approval from the ISG Executive Committee to sell anything at the UIC, with a two-week notice. Food sales are not allowed during Khutbah and during Salah.
- 3. The ISG Executive Committee must approve all vendors and all vendors should be Muslims.
- 4. Approval would mostly be given for food sales. For example, no approval will be given for sale of DVDs or books, and the vendor carrying such material will be asked to remove it immediately. If they refuse, they may be asked to leave and/or stripped of their vendor privileges at the UIC. However, with prior approval from the Executive Committee, sale of clothing or similar items could be allowed.
- 5. The ISG will communicate on any occasional changes or restrictions, for example: "This Friday is a special event for fundraising for the school", etc. ISG reserves the right to carry out this type of fund raiser every now and then. No vendors will be allowed to sell food on these days. If an outside vendor does come, they will NOT be allowed to sell their food until the special event is over.
- 6. ISG is not obligated to provide any tables for vending, but may do so at their discretion and availability of tables for vending purposes.
- 7. After completion, vendors must clean their vending area thoroughly. Since ISG is providing space to the vendors, vendors should take care of the UIC premises.
- 8. All food must be prepared and stored in accordance with local health regulations.
- 9. 10% of proceeds should be donated to ISG based on trust. However, ISG reserves the right to waive the 10% donation requirement for non-profit organizations.
- 10. ISG entities will be given priority over other non-ISG affiliated vendors. During these times, no other vendor may sell meals at the UIC. This is to enable proper planning and minimize waste for the vendor preparing the meals.
- 11. On the days when ISG are NOT selling meals, all for-profit vendors who have prior approval may sell meals, with 10% of the proceeds donated to ISG, as stipulated in item # 9.
- 12. Vendor(s) may be required to relocate their food display or even leave the site based on any emergency situation created by a dispute or disturbance created by the size of the crowd hurting normal operation of ISG
- 13. Upon repeated violation of rules described above, a vendor may be banned for selling food for a minimum of six (6) months.
